#### Mr. Ibrahima Salla

Mr. Salla graduated from Providence University, USA in 1992 with a Bachelor of Science (Honours) Degree in Business Accounting. Over the years, he has attended numerous training programs in Banking, Finance and Leadership amongst others.

He joined the erstwhile Meridian BIAO Bank Group in 1994 and was part of the team instrumental in transitioning Meridian BIAO into Trust Bank Ltd. At Trust Bank, Mr. Salla has held various positions and in 2007, was promoted to the position of General Manager, Corporate Department. This is a position he held until his promotion to Managing Director in July 2016. Mr. Salla will join the Board as an Executive Director in July 2016.
